It shall be the duty of the Anti - Ragging committee to ensure compliance with the provisions of the rule and regulations and any law (for the time being in force) concerning ragging and to deal and act promptly with the incidents of ragging brought to its notice. The anti ragging committee should keep tabs on the happenings/events related to ragging in campus or off-campus within the hostels and other designated places in the premises.

To ensure that the anti - ragging sub committees shall conduct such enquiry observing a fair and transparent procedure and the principles of natural justice and after giving adequate opportunity to the student or students accused of ragging, and other witnesses to place before it the facts, documents

and views concerning the incidents of ragging and considering such other relevant information as may be required.

To monitor, direct and oversee the functions and performance of the anti ragging sub committees in prevention and curbing of ragging in the institution.
